# BNS Settles into A Permanent New Home


Brooklyn Neighborhood Services (BNS) embarks on an exciting new chapter as it moves to a new office location, marking a significant milestone in its mission to serve the community. The organization has settled into 20 Bancroft Place Brooklyn, NY 11233, a mixed-use development that is a part of HPD's Affordable Home Project. The new location will better facilitate BNS' commitment to community empowerment and engagement, enhancing access and expanding outreach efforts along with offering a local platform for hosting community gatherings, workshops, and collaborative initiatives.

This development is one of hundreds of units across six city-owned sites in NYC including Melrose and Crotona Park East in the Bronx, Bedford Stuyvesant and East New York in Brooklyn, Harlem. and Central Collectively. the developments include 440 homes for Older Adults and other New Yorkers at a variety of income levels, including extremely low income and formerly homeless households.

This series of HPD initiatives specifically increase the role of Minority and Women **Business** Enterprises (M/WBE) in city housing and economic development projects. The Bancroft Place development is a 25.762 square foot site and includes 183 affordable residential units. It was developed by two M/WBE firms, Dunbar Development Partners, LLC and Thorobird Companies. Brooklyn Neighborhood Services (BNS) is the Community Development Corporation (CDC) on the site.

BNS expresses gratitude to its board members, staff, and the community unwavering their support throughout this transformative process. The move signifies reinvigorated commitment to serving community's needs more effectively and efficiently.

# More About: United Community Schools



United Community Schools (UCS) UFT is a non-profit organization founded by educators and is part of the United Federation of Teachers, one of the nation's largest and most longstanding teacher unions. UCS originated from the insight of teachers, who recognized the barriers hindering students from reaching their full academic potential and understood the vital need to address those challenges. Such issues include hunger, visual or auditory impairments, and external distractions from issues beyond the classroom.

The UCS community school model intricately links the entire school community - students, educators, principals, and counselors - with broader society, including parents, caregivers, non-profits, local enterprises, and governmental bodies. This collaboration aims to tackle educational, emotional, social, and healthrelated hurdles that obstruct effective learning. Ms. Twila Evanson, the on-site community school director for PS 335, adeptly mobilizes the expertise, vigor, and resources of carefully chosen community entities, such as food banks, healthcare providers, and after-school programs, customized the school's specific requirements.

United Community Schools (UCS) UFT, collaborates with PS 335 Granville T. Woods to implement this service model. Through consulting, professional development, training sessions, workshops, and support materials, UCS assists in embedding this model into the school's framework.

PS 335 Granville T Woods is a public school located in School District 16 Brooklyn, NY. The student population of PS 335 Granville T Woods is 189 and the school serves 3K-5th grade. The school's minority student enrollment is 99%. 89% of these enrolled students and families are economically disadvantaged. There are 16 equivalent full-time teachers.

Together, UCS and PS 335 ensures that all students are equipped to realize their utmost potential not only in the classroom but also in life. This collaborative unity, empowers the school community to elevate and nurture children to their fullest capabilities.

NORC stands for Naturally Occurring Retirement Community, a term used to describe a residential area or community where a significant number of residents are older adults, typically aged 60 and above. These communities aren't specifically designated for seniors but have naturally evolved to accommodate the needs of an aging population.

These communities aim to provide older adults with the necessary resources to maintain independent living while addressing their evolving health, social, and wellness needs. Services within NORCs may include health and wellness programs, transportation assistance, home care, social activities, and access to community resources. Additionally, they might foster connections between neighbors, offering a support network that enhances overall well-being and reduces social isolation among older residents.

NORCs have gained attention for their innovative approach to supporting aging populations, promoting independence, and creating environments where older adults can thrive and remain engaged within their communities.




